Objectives





Most of the available data used to construct the diagrams and take conclusions was based on EUROSTAT. Other data was mostly based on national or regional official statistics.


Key Findings

I started by analysing Manchester's recycling efficiency. My main finding was, when comparing it to Porto, I found Manchester's recycling system to be more efficient but also more costly.







When it came to education, the interesting aspect of it was, when compared to the employment data, how although women in Manchester are a majority in higher education in Manchester, they are in a minority in employment.





A gender issue in Manchester was made more evident when, after comparing it to other European cities, I found that Manchester has one of the lowest ratios of women to 100 men in Europe.

The demographic data also revealed another interesting key aspect of Manchester, that it is one of the youngest cities in Europe, having one of the youngest demographics. The old age dependency ratio, out of the data, makes this clear.



Conclusion

The conclusion I arrived at the end is that Manchester is a positive, involved and very prominent European city. This is evident by looking at the data, take for example, the waste collection or the overall satisfaction with the healthcare, or the positive young demographic.
