We aim to build on professional encounters 2010-2013. Our goals are to advance the methods and understanding of sub-national socio-demographic development in Latin America, to strengthen research networks in Latin America and UK, and to transfer academic knowledge to government planning. We will construct and analyse a database of socio-demographic rates between and within countries: from the International Public Use Microdata Samples, and census and survey data held in REDATAM. We will research and document a sub-national projections system for Venezuelan states and smaller areas, developing a planning-relevant approach to projections in which population, household and labour force projections are integrated.

We will convene three seminars on methods and results, at the Latin American Population Association (ALAP), at the Venezuela statistics institute, and in Manchester UK.

We will use specialist UK software, and explore cost-effective alternatives.

8. Partnership & Mobility Project Report

Plans remain in line with the original application. In the first year the data for sub-national areas across Latin America and the Caribbean have been collated and disseminated as planned, and the Principal Partner has successfully developed a network as described in detail below.

Costs will be vired between headings and years to achieve the same results, with expenditure increased in year 2 compared to year 1. This has been prompted by lower research costs and higher air fares than expected. This has been discussed with and approved by BA and Manchester University research support staff.

The internet services of the external partner have been weaker than expected. Her illness and then pregnancy have led to Brenda Yepez' decision to withdraw as the principal external partner, and her replacement by Leandro Gonzalez, as approved by BA in January 2016. Gonzalez and Simpson have worked together in the past, the team is strengthened by the commitment of another University network, and none of the plans or aims of the project are threatened.

Reports of the work of the project have been submitted for the project website at the University of Manchester and are expected to be live in February 2016.

In the first year, we have concentrated on three parts of the project

(a) Collecting data for sub-national areas across Latin America and the Caribbean.

We have succeeded in making databases of indicators from censuses between 1960 and 2011, referring to 2 billion people, from the collection of public use microdata samples (IPUMS) held at the University of Minnesota.

Research assistance in Caracas supported the construction of further indicators taken from web pages of national statistical agencies, referring to population, fertility, mortality and economic activity.

These have been distributed to the Latin American population studies network and will be the basis for the project workshop and special session at the 2016 Latin American Population Studies Congress. (c) Preparation for activities in 2016.

One workshop and one ordinary session proposed by the project have been accepted by the organisers of the October 2016 Congress of the Asociacion Latinoamericana de Poblacion (ALAP).

An strand on Latin American demography has been proposed for the British Society of Population Studies annual conference in September 2016 – this would be the first time such sessions have been held, and is extra to the plans of the project but will help prepare for the UK activities planned for year 3 of the project.
