Dr. Mukesh Kapila



Dr. Mukesh Kapila is presently Under Secretary General for National Society and Knowledge Development at the International Federation of Red Cross and Red Crescent Societies in Geneva, having served in other senior roles there since 2006.

Previous roles include: Special Advisor

to the United Nations in Afghanistan and to the UN High Commissioner for Human Rights; UN Resident and Humanitarian Coordinator and UNDP Resident Representative in Sudan; Director in Health Action in Crises at the World Health Organization; Senior Policy Adviser to the World Bank Global Facility for Disaster Risk Reduction and Recovery; and Head of Conflict and Humanitarian Affairs at the UK Government Department for International Development.

Dr Kapila is a Senior Member of Hughes Hall College at Cambridge University, Associate Fellow of the Humanitarian and Conflict Response Institute at The University of Manchester and an Associate at the Centre for Global Studies, University of Victoria, Canada. He is chair of the Council of Minority Rights Group International, was an early member of the U.N. Disaster Assessment and Coordination system, and served on the Boards of the U.N. Institute for Training and Research, and the International Peace Academy.

Dr Kapila was born in India and came on a Commonwealth scholarship to high school (Wellington College) in the United Kingdom. He went on to qualify in medicine and public health from the Universities of Oxford and London. He was honored for international service with a CBE and has also received the Dr Jean Mayer Global Citizenship Award of the Institute for Global Leadership.



University Place is a large round building located on Oxford Road (see photo). Buses from Piccadilly Bus Station (14, 16, 41, 42, 43, 43a, 44, 45a, 48, 111, 140, 142, 157, 250) all go past the building. If you arrive at Oxford Road train station simply get any bus from the Oxford Rd bus stop opposite The Cornerhouse. The nearest car park is multi-storey car park D (seen on map) which is accessed via Booth Street West next to the Manchester Business School.
