## What?

Pathways to Law, in partnership with the Sutton Trust, provides information, guidance and hands-on experience to students interested in studying law at university. The 18 month programme is open to students from state schools and colleges throughout Greater Manchester.

Pathways to Law is designed to give you the resources and information to understand what it means to both study and practice law. Students start the 18 month programme in the October of year 12 and carry on until the April of year 13.

All Pathways sessions and work placements are scheduled to sit alongside your studies, taking place in the evenings, holiday periods or weekends, and avoiding any examination periods.

## Who?

We are looking for students who will be beginning 6th form or college in September. Places are limited and will be allocated based on the information given on your online application form. Applications open after GCSE results have been announced and remain open until early October each year.

Students applying to our Pathways programmes must meet the following criteria:

- Attend, and have always attended, a state-funded, non fee-paying school/college
- Be in Year 12 at the start of the programme
- Have achieved 5 A\* – B grades at GCSE (with a minimum of 2 A\* or A grades), including grades 9 – 6 in Mathematics and English
- Live within a reasonable commuting distance of the university
- Have little or no family history of university (your mum or dad didn't go), or have been eligible for Free School Meals, the 16-19 Bursary or the Pupil Premium.
