Unreserved Business

1. Minutes

Noted Francesco had spoken to some, not all, of the hub leaders regarding interviewing applicants.

2. Matters Arising

- <u>Reported</u>
 1. The issue of completion rates was discussed in relation to annual reviews. The possibility of highlighting at what stage the student was at and how much longer they had to go, to the reviewers, was raised. It was suggested that students should include a table of contents for their annual review work. This would provide context for the reviewers.
 - 2. The appointment of TA representative was being undertaken.

3. Chair's Report

- Reported
 1. In respect of the DTC, the School had not been providing any socio-legal methods seminars. Dave Gadd was going to take the lead on organising these.
 2. A supervisors' charter had been sent out. Caroline had been involved in this process and had attained feedback from students
 3. At a Faculty PGR meeting, it had been suggested that supervisors should respond to PGR students within 48 hours. It was felt that a rule should not be set on this and that care needed to be taken not to micro-manage, but that individuals should be targeted. The possibility of circulating a questionnaire to students on this was discussed. Yenkong was in the process of arranging an Open Forum, with the first one being on 15 December, and this could be discussed there.
 4. Five scholarships had been awarded. All but one of the hubs was funded. The one exception was Regulation and Social Justice hub but the candidate had been written to.
 5. A better Legal Ethics programme was reported.
 - *Noted* Clarity on a timeframe for feedback on the final draft of the thesis was needed.

4. Admissions Report

<u>Reported</u> For January 2017 registration, there were 5 unconditional offers (3 home, 2 overseas; 4 law and 1 criminology), 3 conditional offers. There had been a 20% deferral rate from September 2016.
