


### WORLD-CLASS RANKINGS

### **ACADEMIC PEDIGREE**

We are the largest and most diverse grouping of Humanities researchers and teachers within one faculty in Europe. We work with the highest calibre academics across our wide range of disciplines.

We are home to a number of high profile and award-winning colleagues, and have a number of staff who are Fellows of the British Academy and Member Academicians of the Academy of Social Sciences.

#### Our academics include:

- Michael Wood renowned TV historian and broadcaster, and Professor of Public History. Michael has made over 100 documentary films and is a celebrated author.
- Fiona Devine OBE Head of Alliance Manchester Business School, and a Professor of Sociology. Awarded an OBE in 2010 for services to social sciences, Fiona is a leading expert on social stratification and mobility.
- James Nazroo a sociologist and international authority on social determinants of health and wellbeing in later life. Director of the ESRC Centre on Dynamics of Ethnicity (CODE).
- Margot Brazier OBE A Professor in Law, Margot is a Fellow of the British Academy and won the 2014 Manchester International Women's Day Award for Women in Legal and Business.
- Uma Kothari Co-Director of the Global Development Institute, and a Professor of Migration and Postcolonial Studies, Uma was awarded the 2014 Royal Geographical Society's prestigious Busk Medal for research into global development.



## **OUR RESEARCH**

## Our research contributes to the world around us and impacts all areas of society.

Our world-leading academics tackle global issues such as environmental sustainability, climate change, poverty, and conflict response and help bring solutions to some of the most pressing issues facing the world, today, and in the future.

The remarkable breadth of our scholarly activity was demonstrated in the Research Excellence Framework (REF) 2014. Our Faculty made 20 submissions across 17 Units of Assessment (UoA), involving 79% of our eligible staff.

Of the overall research activity in our Faculty, 78% was judged to be world leading (4\*) or internationally excellent (3\*), with 33% at 4\*. This reflects the high standing of the Faculty's publications and other outputs, our research environment and the impact of our research.

Twelve of our 20 UoA were ranked in the top ten nationally. Seven of these were ranked in the top five for Grade Point Average (GPA) or research power: Sociology, Anthropology, Development Studies, Drama, Business and Management, Modern Languages and Linguistics, and Art History. The remaining five were History, Economics and Econometrics, Law, Politics and International Relations, and Education.

Our research ambitions have been supported by over £96.5m of funding between 2009 and 2014. Projects include the British Election Study, Dynamics of Ethnicity, Effective States and Inclusive Development, and the Collaboration for Leadership in Applied Health Research and Care.



## **IMPACT OF OUR RESEARCH**

Our research is making a positive difference to the social and economic well-being of our communities and wider society. We submitted 81 case study examples of our impact, across 20 units of assessment, for REF2014. Our case studies included:

- The theatre of war: support for artists in conflict zones. Our research documents, analyses and enhances the work of theatre artists in, and from, war zones around the world. We have built international networks of artists, developed materials and trained practitioners, and provide an international platform for their work. We also provide online space (www.inplaceofwar.net) where artists interact and share their responses to war, unrest and conflict.
- Our research into the social and economic sustainability of cocoa production, commissioned by Cadbury, led it to switch its supply to fair trade cocoa. The company has now certified its main product lines as fair trade and invested £45 million in cocoa growing communities.
- Our research into working time, working conditions and gender inequalities is being used by the European Commission and the United Nation's International Labour Office to develop employment policy and gender mainstreaming tools.
- Our expertise in health services research and our work as part of the National Institute for Health Research (NIHR) Collaboration for Leadership in Applied Health Research and Care (CLAHRC) Greater Manchester, led to the development and implementation of a post-stroke assessment tool to identify the specific needs of stroke survivors and their carers.



#### **ADDRESSING GLOBAL INEQUALITIES**

The University of Manchester's research beacons are examples of pioneering discoveries, interdisciplinary collaboration and cross sector partnerships that are tackling some of the biggest challenges facing the planet.

The research beacons are:

- Addressing global inequalities
- Advanced materials
- Cancer
- Energy
- Industrial biotechnology

The Faculty of Humanities is advancing understanding of the world in which we live – through the research beacon, 'Addressing global inequalities' – to improve lives.

We are focusing on all aspects of inequality, from poverty to social justice, from living conditions to equality in the workplace. We seek to understand our world and directly change it for the better.

We have many years of experience in research in global development, education, disaster management, humanitarian aid, employment and equality and diversity, and are helping to deliver real-world benefit.

Our research directly influences policies which make positive changes for people living in poverty and inequality. International governmental organisations, national governments, multinational corporations, global charities and non-governmental organisations partner with us to do things differently.



## **POSTGRADUATE RESEARCH**

We offer world-class training, supervision and facilities to our postgraduate researchers. Our doctoral researchers pursue intellectually challenging projects within a stimulating and collegial environment. They are part of a diverse, interdisciplinary postgraduate community that reaches beyond the University.

#### We:

- Lead the Arts and Humanities Research Council (AHRC) North West Consortium Doctoral Training Partnership (NWCDTP) and are the largest partner in the Economic and Social Research Council (ESRC) North West Doctoral Training Centre (NWDTC). Through these we offer studentships across the full range of arts, humanities and social sciences subjects and bring together doctoral researchers from across the region.
- Work in partnership with institutions outside the higher education sector to enable postgraduate researchers to produce research with a broader relevance and to develop their knowledge exchange and employability skills.
- Partner in the AHRC Centre for Doctoral Training: CEELBAS (Centre for East European Language-Based Area Studies).
- Provide studentships through the University's flagship Presidential Doctoral Scholarship Award Scheme.
- Provide excellent interdisciplinary training and researcher development opportunities through methods@manchester, artsmethods@manchester and our dedicated Researcher Development Team.
- Invest more than £6m each year from internal and external sources in support of our PG researchers.

#### **EXECUTIVE EDUCATION**

In addition to our undergraduate and postgraduate programmes, we deliver executive education to often highly-experienced people employed in the private and public sectors, to better equip them to tackle the challenges of working in their business environments.

- Themes include: Leadership, Strategy, Creativity, Finance and Accounting, Marketing, Managing People and Innovation.
- The Executive Development Centre (EDC) is the home of executive education within Alliance Manchester Business School . A new executive education centre is being developed, that will include a 300-room premium hotel and state-of-the art teaching facilities.
- Programmes are provided as either open attendance, allowing for a mix
  of public and private sectors to interact during the learning, or
  customised to the specific issues and needs of a particular organisation.
  They are delivered across numerous disciplines within Humanities but
  also use the expertise of the other Faculties at the University.
- Programmes are delivered in Manchester and also globally, in conjunction with the Alliance Manchester Business School worldwide presence in cities such as Sao Paulo, Miami, Dubai, Shanghai, Hong Kong and Singapore. We can also deliver programmes at the client's site.
- Our clients include public and private sector organisations like: National Health Service (NHS), Shell Eurocard, Thales, Honda Europe, Manchester Airports Group, BP, China Development Bank, Ministry of Finance (China), Al Futtaim (UAE), MITIE and The Co-Operative Group.



## SOCIAL RESPONSIBILITY

Social responsibility is one of our three core strategic goals and describes the way we are making a difference to the social and economic well-being of our communities through our teaching, research and public events and cultural activities.

- The University of Manchester is the number one organisation with SGOSS (School Governor recruitment specialists) for registrations of volunteers to be School Governors. In Humanities 39 staff and 168 alumni act as School Governors.
- Almost 200 Humanities staff engage with Policy@Manchester, a network which mobilises knowledge in research and teaching to influence and inform public policy, and to create a focal point for public policy research and expertise at the University.
- The Legal Advice Centre offers free legal advice to the public while providing practical experience for our Law students. Advice includes housing, family, consumer and employment. We also have new clinics for deaf people and dementia sufferers, and support Manchester's Chinese community.
- Multilingual Manchester was set up in 2010 to document, protect and support the 200+ languages spoken in Greater Manchester.
- Our Prometh3us programme a three-day leadership and executive education event – attracts over 100 participants from across UK charities, non-governmental organisations (NGOs) and third sector organisations.
- More than 26,000 members of the public attend lectures, seminars and events run by Humanities annually.
