Analysis of data from across the Home Office's main areas of responsibility to increase our understanding of cross-cutting issues. This work pulls together evidence on cross cutting themes to inform policy makers and Ministers on key strategic priorities. Current examples include understanding the multiple characteristics making certain people and places vulnerable.

#### Data sources:

The project involves creative thinking around the range of data sources available across the Home Office and in a number of other government departments and stakeholders (eg Office for National Statistics, Ministry of Justice, Public Health England).

#### Key data sources include:

- Crime Survey for England and Wales;
- Police National Computer;
- Police Recorded Crime and Police.uk
- Public Health England data

Desirable: Data presentation and visualisation skills

Preferred selection method: Interview (in London)

### Support and training offered by the organisation:

Home Office: Analysis and Insight is a learning organisation. All Q-Step placements will be allocated an experienced analytical line manager for the duration of their placement. The line manager will guide the student through their projects.

Introductions to Home Office analysis and policy making will be available to Q-Step placements. Coaching in data sources, analytical skills, and communicating with policy and stakeholders will be available. Some online training will be offered. However, we expect Q-Step placements to be self-starters: seeking out opportunities to learn and advance thinking themselves.

#### **Supporting Information:**
