Programme structure

Here, some key points are indicated by way of introduction. You should familiarise yourself with the Handbook in the first few weeks of your studies and refer to it throughout your programme.

The PhD and MPhil programmes are structured through a combination of supervised research, research training and researcher development. You will begin work on your research from the start date of your programme with support from your supervisory team.

The normal expectation is that you should meet with your supervisors at least once a month throughout the programme but, in discussion with them, you may well meet much more frequently at important points in your research.

Research training is available at School, Faculty and University levels and your training needs and requirements are an important part of discussion with your supervisors.

Researcher development is also available and consists of further training provided by the Faculty of Humanities under the Researcher Development Framework. The main focus of this is on the personal and professional skills required to produce a high quality PhD.

It is a requirement of the University that formal mechanisms are in place to ensure that all students make progress on their programme, with a view to submitting a high quality thesis within the permitted timeframe. Academic progression and monitoring for PGR degrees is governed by the University's Policy on the Progress and Review of PGR students (September 2015) which forms part of the University's Code of Practice for PGR.

Your progress will be monitored via eProg, which is a University-wide system that is specifically designed to help to structure your programme and enable both you and your supervisors to monitor your progress.

Progress is also monitored via formal 'Progress Reviews,' which are meetings that are held twice a year. Satisfactory progress is a condition of being allowed to continue to the next year of the programme.

Facilities

Postgraduate research study rooms

All School of Law postgraduate research students are entitled to use of a desk and computer in one of the School's rooms designated for this purpose. Information about the availability of desks in the PGR study rooms will be provided during welcome week. The University of Manchester Library, a designated National Research Library, offers a range of services that directly underpin research at Manchester. This includes the provision of research support facilities across campus, access to an unparalleled range of electronic resources including over 40,000 e-journals and a comprehensive range of research datasets.

The Library operates across a number of sites. The Main Library offers group study rooms, individual study spaces and computer clusters. WiFi is available throughout the building and a cafe lounge is located on the ground floor.

The Alan Gilbert Learning Commons provides a state of the art 24/7 learning environment, offering flexible open learning spaces, multimedia facilities, computer clusters and bookable group study rooms plus runs a wide range of study skills workshops throughout the academic year.
