

Accounting and Finance lie at the heart of modern business; and the need for specialist knowledge can never be under-estimated in the modern business environment. Our degrees are designed to give you an in depth understanding of both the theory and practice of Accounting and Finance.

The University of Manchester is one of the best universities in the UK for teaching and research in Accounting and Finance. It was one of only two institutions to be awarded the highest 5* rating in the most recent Research Assessment Exercise. External surveys of graduate recruiters in the field have consistently voted us in the UK's top three. We also have strong links with three main UK accounting bodies: ACCA, CIMA and ICAEW, as well the 'Big 4' accounting companies and other large graduate employer organisations.

The teaching of accounting and finance is underpinned by a commitment to examining the subjects from a broad social science perspective with first year modules available in Economics and other social sciences subjects. 

World-leading research and teaching economics has been at the heart of research in Manchester since the early days of the University. William Stanley Jevons (1835-1882), who had neoclassical economics, was one of the first professors at Manchester. Sir John Hicks (1904-1989) wrote his most important works on welfare economics during his time at Manchester. He was awarded the Nobel Prize in 1972 for his contribution to microeconomic theory. Sir Arthur Lewis (1915-1991) was awarded the prize in 1979 for his pioneering work in the field of development economics, work that he initiated and shaped in Manchester. More recently, Joseph Stiglitz (Nobel Prize winner 2001) has led the Brooks World Poverty Institute at Manchester. The first Chair in econometrics at a UK university was established at Manchester in the

Today, the Economics discipline area within the School of Social Sciences is one of the largest in the UK, with more than 50 academic staff, including 16 professors.

In the most recent Research Assessment Exercise (RAE 2008), we received international recognition for the quality and impact of all our research activity, with 80% of our research work achieving the highest standards of international excellence.

We are proud to be acknowledged throughout the world as a leading centre for economic research, scholarship and research-led teaching in all areas of the discipline, including microeconomics, macroeconomics, econometrics, financial economics, environmental, development economics and industrial/business economics. As such, we attract leading academics and the best students from all around the world, and received a maximum score of 24/24 in the latest assessment of our teaching quality.

ECONOMICS

BEconSc ECONOMICS



This is our single honours course for Economics specialists.

It is a quantitative economics course, and as such you will need to have a strong mathematical background and intend to advance your knowledge in order to become a skilled economist, able to proceed to postgraduate training in the best universities, or on to a career in a renowned organisation, in either the private or public sector.

Modern professional economists need to have a clear understanding of economic principles in order to recognise and model relevant economic problems, and they need to be equipped with mathematical and econometric tools in order to solve and analyse such problems. The BEconSc degree provides you with the required training by having at its core a compulsory stream of units in economic principles, mathematical modelling and econometric techniques.

Degree Specialisms

The degree is structured so that you can combine core units in economics and quantitative methods, with the opportunity of further specialisation in area of particular interest to you for example:

- Finance: A popular option if you are looking to work in the City, have a particular interest in financial or monetry issues, or are interested in postgraduate training and research in Economics and Finance
- International and Monetry **Economics:** aimed at students interested in international trading issues, such as the EU, development and globalisation, and those with an interest in monetary Economics.
- Business Economics and Applied Microeconomics: encompasses the study of the structure of organisations and markets. labour marketed. environmental and resource economics, as well as management science and managerial economics.

In this way, your focus can be linked to the kind of career you wish to pursue after graduation.

Irrespective of the particular area you are focusing on, employers look for candidates who can produce sound and clear reports that make sense of the available data using advanced quantitative skills in analysis and modelling. Year 1 gives you a broad introduction to the social sciences, enabling you to make an informed choice of areas to specialise in for your second and third years.

Compulsory units:

- Microeconomics*
- Macroeconomics*
- Maths*
- Statistics*

Optional units:

- All students take at least one Politics module
- All students take at least one social sciences module, from a choice of Criminology, Philosophy, Sociology and Social Anthropology
- An Introduction to Development is available for students wishing to pursue Development Studies as a single or joint specialism
- Other options include Finance, Computing, History and Study Skills course.
- *Mathematics and Economics courses are designed to accommodation your previous academic experience i.e. post GCSE/AS/A Level.

Year 2

It is at this stage that you begin to specialise. You can take a maximum of 80 credits from a single subject area. Most second year students specialise in two or three areas of study, since this keeps your options open and ensures that in your third year you still have a choice of areas of study rather than limiting yourself to just one.

In the second year you also have the opportunity to study abroad, or take credits in a language. You could also take the Manchester Leadership Programme, which is run the Careers Service. For more information go to

Our PPE degree is a structured yet flexible course, informed by cutting-edge current research, in which you study significant topics, questions, and problems in contemporary politics, philosophy, and economics. It enhances your ability to analyse and evaluate competing arguments about political events, ideas, and institutions; it gives you an understanding of economic systems and theories and places the study of economics in its broader institutional and political context; and it develops your ability to formulate rigorous arguments and philosophical positions.

Student Induction

An induction programme for all new students takes place during Welcome Week to help you settle in. This includes:

- Welcome talks
- The opportunity to meet students on your course and other courses within the School of Social Sciences
- Meetings with your programme director, student support staff and your peer
- Presentations from key University services
- The opportunity to join student societies and various social events

Pastoral care

All new students are assigned an Academic Advisor who will provide you with support and advice in one-to-one meetings at regular intervals throughout your degree. Lecturers and course directors hold weekly Office Hours to discuss any aspect of individual course units.

Student mentor scheme

We operate a peer mentoring scheme which provides first year students with a second or third year trained mentor who will be able to provide practical assistance with settling into student life. Sometimes there may be things that you feel more comfortable discussing with other students rather than university staff. In this case, mentors are extremely beneficial, and can help you to make the most of your time at Manchester, both academically and socially.
